Youth Leadership Coordinator (Part-time)

We also provide support to Americans who are sponsoring refugees for resettlement.

In welcoming peoples fleeing persecution and conflict, we are honoring our national heritage as a country of immigrants as well as our commitments under U.S. and international law. IRIS helps newcomers with services and support critical to their transition to self-sufficiency and to making local communities across the U.S. their home.

IRIS is looking for a Youth Leadership Coordinator to develop and facilitate programs for immigrant youth. The Youth Leadership Coordinator will work with the education team to help IRIS youth build a sense of belonging, develop academic skills, especially English proficiency, and acclimate to the New Haven community.

General Description:

The Youth Leadership Coordinator will serve as a staff facilitator and organizer for an after school and summer Youth Leadership Program. The goals of the program are to build English and literacy skills, to help teens and young adults form and deepen friendships across differences, to explore New Haven, to learn about civics and social justice topics, to develop confidence, and to engage in activities that allow for creative self-expression.

Essential Duties and Responsibilities:

Youth Leadership Program Coordination

- Plan and facilitate youth leadership sessions alongside co-leader
- Implement activities based on the needs of the youth participants and the goals of the program
- Tutor students in various academic subjects, with a focus on English reading and comprehension to support language acquisition
- Incorporate restorative practices and social emotional learning
- Help plan and chaperone a summer multi-day field trip for youth (dependent on annual grant funding)
- Keep accurate attendance records and manage participant data
- Assist with the setup and cleanup of the program space before and after activities.
- Strive to implement best practices and seek out opportunities for continuing training as a

youth facilitator

• Monitor and evaluate program effectiveness, providing feedback and suggestions for improvement

This position is grant-funded. Grants typically fund for a period of one year. Extension grant-funded employment is subject to the availability of funds.

In submitting an application for employment, the applicant grants IRIS permission to check references as well as question anyone who might be familiar with the candidate's job performance.

Requirements:

The position is accessible to people of varying skill levels and experience. However, priority will be given to applicants with the following qualifications:

- Applicants who identify with historically underrepresented groups in college and professional paths who will be able to mentor refugee and immigrant youth in navigating their lives are especially encouraged to apply
- Experience working within the immigrant community
- Ability to troubleshoot and overcome unexpected challenges
